Participation, Release, and Indemnification Agreement

PARTICIPANT'S AGREEMENT TO ASSUME THE RISK OF PERSONAL INJURY, DEATH AND PROPERTY DAMAGE ASSOCIATED WITH ACTIVITY PROGRAMS, AND TO RELEASE AND INDEMNIFY CAMP ARROWHEAD CAMP AND CONFERENCE CENTER THEIR OFFICERS, DIRECTORS, EMPLOYEES AND AGENTS FROM AND AGAINST ANY AND ALL LIABILITY AND COST IN CONNECTION WITH THE PARTICIPATION IN ALL ACTIVITY PROGRAMS AT CAMP ARROWHEAD.

ACKNOWLEDGEMENT OF RISK, WAIVER, RELEASE AND INDEMNIFICATION

WHILE CAMP ARROWHEAD MAKES EVERY EFFORT TO PROVIDE A SAFE AND PLEASANT ENVIRONMENT FOR OUR GUESTS, WE DO REQUIRE THAT THIS PARTICIPATION AGREEMENT BE READ, FILLED OUT, SIGNED AND DATED BY EACH GUEST OR THE PARENT OR LEGAL CUSTODIAN OF EACH CHILD UNDER 18 YEARS OF AGE WHO WISHES TO PARTICIPATE IN THE ACTIVITIES WHICH OCCUR AT CAMP ARROWHEAD.

Although Camp Arrowhead has taken reasonable steps to provide equipment and skilled employees so our guests can participate in activities for which they may not be skilled in, we now remind you that these activities are not without risk. Certain risks cannot be eliminated due to the Camp's rural setting and without destroying the unique character of those activities. The same elements that contribute to the character of these activities can be the cause of loss or damage to your property, accidental injury or illness or, in extreme cases, permanent trauma or death. We do not want to frighten you or reduce your enthusiasm for these activities, but we do think it is important for you to be informed and know in advance about inherent risks. You hereby attest as follows:

I have asked to participate in the Camp Arrowhead Camp and Conference Center Activities Program and related events. I understand that participation in these activities is not without risk.

I understand that no activity program is absolutely safe and free of risk. I agree to assume full responsibility for myself and that of my family, including minor children. I agree to assume full responsibility for myself and that of my family, including minor children. I expressly assume all risk and responsibility involving accidents sustained while participating in activity programs at Camp Arrowhead Camp and Conference Center resulting from negligence on my part, that of my family or employees, officers, directors or agents of Camp Arrowhead Camp and Conference Center.

I affirm that I am fully capable of participating in this activity and that my general health is good., that I do not have any condition that might endanger the life or health of myself or others participating in this activity. I affirm that I know of no reason why I should not participate.

I understand that as a participant, I (or my child) may be photographed or videotaped during normal Camp Arrowhead activities and these photos/videos may be used in promotional materials.

If any provisions of this Agreement shall be construed to be illegal or invalid, it shall not affect the legality or validity of any of the other provisions herein, those portions shall be deemed stricken and deleted from this agreement, but all other provisions of this Agreement shall continue in force and effect.

In consideration of, and as part of payment for the right to participate in activities arranged for me by Camp Arrowhead Camp and Conference Center, I waive all claims and do hereby assume all the above-described risks and any other ordinary risk incidental to the nature of the program, including risks which are not specifically foreseeable, and will indemnify and hold Camp Arrowhead Camp and Conference Center and its directors, officers, employees, agents, and/or associates, and their heirs executors, and administrators harmless from any and all liability, actions, causes of action, debts, claims and demands of every kind and nature whatsoever may arise from or in connection with the program or participation in any other activities arranged for me by Camp Arrowhead Camp and Conference Center and their representatives.

The parties accept the Holy Bible as the inspired Word of God. They believe that God desires that they resolve their disputes with one another within the Church and that they be reconciled in their relationships in accordance with the principles stated in I Corinthians 6:1-8, Matthew 5:23-24, Matthew 18:15-20 and other pertinent scripture.

The parties agree that any claim or dispute arising from or related to this agreement and their relationship shall be settled by Biblically based mediation and, if necessary, legally binding arbitration in accordance with the Rules of Procedure for Christian Conciliation of the Institute for Christian Conciliation, a division of Peacemaker Ministries.

The liability release and indemnification agreement shall be legally binding upon my heirs, assigns, legal guardians, personal representatives, and myself. I have carefully read this agreement and understand its contents. I am aware that I am releasing certain rights that I otherwise may have of my own free will.
