GUIDELINES & INFORMATION

FOR CAMP STAFF

Expectations for Staff:

- ❖ All staff must have their pastor or Children's Pastor to complete and mail a Pastor's Recommendation Form. (Included in the packet sent to all churches.)
- ❖ All Adult Workers will be required to have a criminal and sex offender background check. If your church has a background check on file we must have a copy of that information. The church or school holding the file should send the report to the Camp Director. If no background check has been made we will do one.
- ❖ Counselors will be required to supervise approximately 24 children 24 hours a day. (Periodic breaks will be given.)
- ❖ Medical problems that may limit your activity must be explained on your application.
- ❖ Come rested and ready to have fun with your campers!
- ❖ Arrive for orientation the first day of camp at 9:00 AM sharp! (A Counselor training class will be held Monday before Kidz Camp at 3:00 PM. We ask that no camper arrive at that time)
- ❖ Exhibit a Christ-like example at all times.
- ❖ Attend all chapel services.
- ❖ Be on time to your scheduled activities.
- ❖ Be aware of children who need special attention.
- ❖ Staff under 18:
 - Must get approval from the Director to make phone calls. (No exceptions.)
 - Must turn in their car keys to the Director.
- ❖ Do not make phone calls when children are present—this only makes them want to call home.

Notes:

Staff orientation will be at 9:00 AM in the Thompson Family Life Center. Camper registration will begin at 11:00 AM. The Training Session July 9 will be held at that same location.

During the orientation meeting playground / gym monitors will provide supervision for children who arrive with staff. *No one will be allowed in the dorms until after the staff meeting.*
